# **County treasurer raises audit report concerns**

Massac County Treasurer Jody Haverkamp has contacted the Illinois comptroller's office with concerns regarding the county's 2020 audit report.

According to Haverkamp, the report filed by Beussink, Hey, Roe & Stroder, LLC, is not what she approved. According to the Comptroller's Office. Haverkamp wants

There was no treasurer's report since Alison Boyt had not yet received the bank statements to reconcile figures. The collector's report of \$73,886.53 was also not reconciled. Boyt will email aldermen after she receives the statements.

Bills totaling \$32,023.21 were approved payment by council. Out of the DCEO grant, authorization to pay for cement sealant in the amount of \$502.64 for the new maintenance building was made. A third payment from that grant, of \$13,250 to Southern Five Regional Planning, was also approved. In addition, payment of application No. 3, totaling \$189,801.58, which includes the \$4,535.30 for the electrical upgrade, was approved from the same DCEO grant.
